STATEMENT OF CLAIM

- 1, The Plaintiff is 66 years old and a native-resident of Okohia in Isiala Mbano Local Government Area of Imo State.
- 2, The Plaintiff attended the University of Lagos, securing a Bachelor of Science Degree in Business Administration and a master's degree in Management.
- 3, The Plaintiff worked for over 15 years at First Aluminium and then at Tower Groups. He became Executive Director of Alucon in 1997, and later became Chairman of Mekalog Group, an engineering firm supplying the defense, security, construction, fabrication, oil and gas sectors.
- 4, The Plaintiff has been married for 41 years to Her Excellency, Mrs. Chioma Ohakim, Esq and they have five children. I and several grandchildren.
- 5, The Plaintiff was appointed Commissioner for Commerce, Industry and Tourism of Imo State from 1992 to 1993.
- 6, The Plaintiff is one of the founding members of the People's Democratic Party (PDP) in Imo State, and he remained a PDP member until November 2006, when he became a member of the Progressive Peoples Alliance (PPA), under which platform he contested, won and was sworn as the Executive Governor of Imo State on May 29, 2007.
- 7, The Plaintiff has four published books to his credit, namely: 1. "The Marketing Imperative for Rural Industrialization" (Africana Educational Publishers); 2. "Pushing

the Limits"; 3. "The Courage to Challenge; and 4. "Challenging New Frontiers" (a collections of speeches).

- 8, The Plaintiff is a titled Chief, holding 51 Chieftaincy titles, including the Ogbujingidi of Igboland and Otunba Temitope of Yorubaland; and he was the Accord Party candidate in the 2019 Imo State Governorship election.
- 9, The Plaintiff is a mentor to many across Nigeria, including particularly the thousands of people he has positively impacted their lives through his stellar political and business career, spanning decades.
- 10, The Defendant is a native-resident of Nwangele Village in Umuorlu Town, Isu Local Government Area, in Imo State.
- 11, On or about 23rd April, 2023, the Defendant recorded in his own voice an audio which he put in the stream of viral circulation through WhatsApp social media platforms. The audio was widely listened to by many worldwide, particularly in Nigeria and Imo State. The said audio which has been reproduced verbatim and is hereby attached and made part hereof contained the following excerpted libels uttered against the Plaintiff by the Defendant:

"Athan himself met with me at Protea hotel and as we were discussing, he got a call from Ikedi Ohakim from the call he asked Ohakim where is the meeting holding? Ohakim answered him that is holding in his house and he asked him did you know my house? Athan said no, Ohakim told him to ask people to bring him to his house. Sen. Athan asked me to take him to Ohakim house, I did personally and when I got there, I saw Osita Nwaneri, I saw Ilomuanya, I saw Maxwell Duru etc. When I saw these people I was shocked because these people are members of Elder Council of APC, what could bring Sen. Athan to their meeting, being a Labour Party Aspirant, I came with Ajumbe, the Organizing Secretary Labour.

We went back to Protea hotel, there I asked one Austine who's an assistant Organising Secretary of APC what kind of meeting they called this man? And the man told me that they called him this meeting for him not to fight/contest this election with Hope Uzodinma. As Elders Council of APC what is their business with somebody in another party (Labour).

S,o after the Labour Party primary as it went, that was when somebody told me that that day Sen. Athan went to that meeting (at Ohakim house) was the day he signed an oath, agreement with the Elders Council of APC before Hope released One million dollars to him. Because Sen. Athan has no money in recent time, how did all this money come out from him, he took the money & passed it through the PDP members, I saw the PDP members in the hall who were delegates, and I began to worry why this PDP member is in the Labour Party primaries; not just there but also there as delegates. ...".

- 12, In summary, the Defendant made and published the foregoing audio allegations, purporting that the Plaintiff was complicit in and a participant in the conduit used to corruptly channel \$1,000,000 (One Million US Dollars) bribe which was used to corruptly influence the outcome of the Labour Party gubernatorial primary that was conducted in Imo State recently.

- 8, On or about 23rd April, 2023, I received an audio message on my WhatsApp Messenger that I recognized the voice thereon to be that of the Defendant. The details of the mobile phone to which I received the said audio are as follows:
- (a). Model: Nokia.
- (b). Model Number: Nokia 4.2.
- (c). IMEI Number: IMEI 352900105960699.
- (d). Duration of Use: Since October, 2019.
- 9, The said audio which was transcribed and reproduced verbatim to **Compact Disks** from my mobile phone by the Plaintiff's Expert Witness, **Mr. SUNDAY PRINCE EMEKA**, contained the following words uttered against the Plaintiff by the Defendant:

"Athan himself met with me at Protea hotel and as we were discussing, he got a call from Ikedi Ohakim from the call he asked Ohakim where is the meeting holding? Ohakim answered him that is holding in his house and he asked him did you know my house? Athan said no, Ohakim told him to ask people to bring him to his house. Sen. Athan asked me to take him to Ohakim house, I did personally and when I got there, I saw Osita Nwaneri, I saw Ilomuanya, I saw Maxwell Duru etc.

When I saw these people I was shocked because these people are members of Elder Council of APC, what could bring Sen. Athan to their meeting, being a Labour Party Aspirant, I came with Ajumbe, the Organizing Secretary Labour. We went back to Protea hotel, there I asked one Austine who's an assistant Organising Secretary of APC what kind of meeting they called this man? And the man told me that they called him this meeting for him not to fight/contest this election with Hope Uzodinma. As Elders Council of APC what is their business with somebody in another party (Labour).

So, after the Labour Party primary as it went, that was when somebody told me that that day Sen. Athan went to that meeting (at Ohakim house) was the day he signed an oath, agreement with the Elders Council of APC before Hope released One million dollars to him. Because Sen. Athan has no money in recent time, how did all this money come out from him, he took the money & passed it through the PDP members, I saw the PDP members in the hall who were delegates, and I

began to worry why this PDP member is in the Labour Party primaries; not just there but also there as delegates. ...".

- 10, To my ordinary understanding, the summary and main point of the words uttered by the Defendant in the published audio are that the Plaintiff was complicit in, and was also the lead participant in the conduit or arrangement used to corruptly channel \$1,000,000 (One Million US Dollars) bribe which was used to corruptly influence the outcome of the Labour Party gubernatorial primary that was conducted in Imo State recently.
- 11, To my mind, the content of the said audio portrayed the Plaintiff to the general public in the following light:
- (a). A deceitful person.
- (b). A morally depraved person.
- (c). An irresponsible and corrupt person.
- (d). An anti-democratic person.
- (e). A political operative for hire.
- (f). A person who entices others to engage in anti-democratic practices.
- 12, I have discussed these libelous words of the Defendant against the Plaintiff with my circle of friends and acquaintances, especially the many that know and respect the Plaintiff and they insist that unless this Honorable Court holds otherwise, the Plaintiff shall forever remain guilty of the Defendant's assertions in the said audio.
- 13, Whereof, I depose to this Witness Statement in good faith believing same to be true and in accordance with the Oaths Act in force.
